The Manfred house structure is an iconic design that must remain on the bluff overlooking Rock County. It is a priceless example of a modernist prairie home that cannot be duplicated. Please provide for the preservation of the structure. Some changes may be acceptable to minimize costs if necessary.

We lived in Luverne from 1960 to 1964 before the area was named a State Park. The Manfred family were personal friends of our family. We watched the school house come down and the stone moved back to the bluff where the house was built. We shared in the family's dreams and disappointments over the construction problems as the house progressed. We are pleased with the development of the property as a State Park and have visited it when we are in the area. The architectural design of the house is unique to the prairie/cliffside landscape in accord with Dakota environmental concepts. No other dwelling incorporates this architectural design in the Dakota area. Fred Manfred's novels vividly portray the encounter of the Dakota and white settlers in this area of Minnesota, Iowa, and eastern South Dakota. The loss of this architectural treasure would be devastating to the rich Dakota heritage in Southeastern Minnesota. Do not demolish the house - USE IT!

I think the best "value" to the residents of Minnesota would be to take steps to preserve the history and character of this important location by renovating the Fredrick Manfred house to be used as an interpretive center.

Look at the photograph taken by Jim Brandenburg of all the people sitting outside at the Manfred House. You can see the horizon and the great expanse of prairie from there. I'm sure you can easily imagine a young person visiting that house, standing outside and looking out at that horizon and thinking "I am going to do everything I can to preserve the prairies and to respect the stories of the people who once lived here." Don't deprive future generations of writers and environmentalists of that chance.

Don't take down the historic house

I feel there should be a stronger commitment to preserve more of the original home site. It is a cultural landmark and because of expediency and other political considerations the big picture is lost, it is common to not recognize this. There has been considerable effort and private expense in preserving the local Sioux Quartzite structures in Luverne. I feel it should be a cultural commitment to retain more of the character of the house structure. A compromise between the complete dismantling and a complete rebuilding seems appropriate. A design which allows free air to flow through large open spaces should remedy the water issue. Much emphasis could be placed here to explain the prairie flora and fauna (especially the bison herd) which is the main focal point of the park.

Much local private effort and funding has been a serious commitment in preserving the nearby Touch the Sky Prairie. Millions of dollars have been invested to preserve the natural prairie heritage. It seems there could be some effort here at the Manfred home site to do something to preserve this important cultural heritage. I think some basic measures should be taken to preserve what is there now and have a historical preservation architecture firm or group determine its future. I think this firm does not

have the qualifications to assess value, process or direction.

Do not remove the Manfred house

Frederick Manfred was a great writer and built a unique house. I would like to see the house preserved and used as a way to help people learn about the Blue Mounds in general and the equinoctial wall in particular.

None of these designs include the Manfred House. It should remain where it is.

Of course this park needs and ought to have an Interpretive Center. While some of Manfred's work is dated, and perhaps not as relevant as the indigenous story of the land, the house is beautifully designed to fit in the landscape and has historical value. If it is torn down, someone will eventually want to build another one which will cost millions. Keep the house, get funding from the legislature or perhaps sponsor an architectural design contest to update it. It's a valuable asset and feature of the site.

Demolition of a National Register-eligible historic resource should not be included in the only available options.

Put a nice plaque near the trailhead with the appropriate tribute to Mr. Manfred's writing. And to the man who was the best steward of the land, my dad Vernon Noll. He did not scar the landscape and farmed it wisely and without disruption to the beautiful land. I have many wonderful childhood memories of growing up in the "Blue Mounds." Please allow all future generations to enjoy it like I did: without structures at the top of the cliff line, obstructing the beautiful rock outcroppings.

The TKDA condition assessment probably overstated the case to tear the house down. Without gaining entry to the interior of the structure it was irresponsible to condemn a structure that may be eligible for listing on the National Register. It looked like the assessment team was climbing on the roof, so admitting them to assess the interior would not have presented any more safety risk.

The original house which stands on this property (now apparently collapsing from complete failure to care for the building) is not only the former home of a great Minnesota writer, but a structure which allowed for visitors to view the land from an elevated perspective, as well as to use for events and staff offices. Saving and protecting that building would have been the best use of tax dollars. Good lord! Public dollars!! Get historical preservationist dollars involved. Don't make mistakes that can't be remedied. There are many of us who would help.

The existing visitor center/Manfred House is one of the characteristics that would draw me to the site. Based on the photographs I have seen, it reminds me of the Temppeliaukio Church in Helsinki, which is also built into the rock and which dates from the same approximate time period. That building in Helsinki is a spiritual and reflective place, and one of the most-visited attractions in Helsinki (see <https://www.myhelsinki.fi/en/see-and-do/sights/temppeliaukio-church>). But, because it was one of my favorite things to do, my grandpa agreed that he would stay behind and walk with me. I didn't know it at that time, but my grandpa was in the early stages of Alzheimers. I remember walking up atop the Blue Mounds above the hill behind the Manfred House and sitting down on a rock with my grandpa to watch the sunset. As we sat there, my grandpa told me that whatever happens, he wanted me to know that he loved me and I remember thinking that he seemed worried about something that he wasn't saying.... This was the last memory that I have of my grandpa when he was still able to remember my name. I am now 25 years old, but the memory of sitting there on a rock atop the Manfred House with my grandpa is something I will never forget. It means everything to me.

I know that I am not alone in having cherished memories at the Manfred House. And, I know that if this historic place were to be torn down without first considering public opinion, I would not be alone in forever losing a touchstone back to these memories. I ask that you please do everything in your power to first consider any alternative options for the reconstruction of the Manfred House and take note of the public opinion regarding the invaluable worth of the house itself as a historic location.

The Manfred House, a National Register-eligible property, and key part of this site, should be preserved, maintained, and used in its historic form for public programming. As a native Luvernite, I grew up with this site and have spent countless hours in the park, walking its trails and enjoying the prairie (with the house there). I know it hasn't been regularly maintained over the years; that was obvious while I was growing up and since. It disturbs me that the DNR would put out this survey and NOT have an option to preserve the house.

There are no cost figures associated with the three design concepts, so no comparison is possible with renovation of the existing structure. Furthermore, the intangible value of the existing structure has not been taken in to account in the planning process itself.

The Manfred house is a local historical structure, is beautifully woven into the fabric of the landscape, and has significant potential to enhance this area of the park.
